



Privacy Policy

By using our website and purchasing O2PR Tokens, you consent to the collection, use, and disclosure of your information in accordance with this Privacy Policy.

Information We Collect

1.1 Information You Provide to Us: We collect information that you provide to us when you use our website and participate in our ICO, such as your name, email address, wallet address, transaction information, and information provided through web3 technology wallet connection.

1.2 Automatically Collected Information: We automatically collect certain information about you when you use our website, such as your IP address, browser type, device type, operating system, and website usage data.

Use of Information

2.1 We use the information we collect to:

Process your purchase of O2PR Tokens;
Communicate with you about our ICO and other O2 Protocol updates;
Improve and optimize our website and ICO;
Prevent fraudulent activity and protect the security of our website and ICO;
Enable web3 technology wallet connection and transactions; and
Comply with legal obligations and enforce our Terms and Conditions.

2.2 We may also use the information we collect for other purposes that are compatible with the purposes for which we collected it, or as authorized by you.

Disclosure of Information

3.1 We may disclose your information to:

Our affiliates, service providers, and advisors who help us operate our website and ICO;
Governmental authorities and law enforcement officials, when required by law or as necessary to protect our rights or the rights of others; and
Third parties in connection with a merger, acquisition, or sale of all or a portion of our assets.
3.2 We may also disclose your information to other third parties with your consent or at your direction.

Cookies and Similar Technologies

4.1 We use cookies and similar technologies to collect information about your website usage and preferences.

4.2 You can control the use of cookies at the individual browser level. However, if you choose to disable cookies, it may limit your use of certain features or functions on our website.

Security

5.1 We take reasonable measures to protect your information from unauthorized access, disclosure, or use. However, no security system is impenetrable, and we cannot guarantee the security of your information.
